Applying for early childhood education or a club and enrolling for pre-primary education

A child's guardian can submit an application for early childhood education or a club and enroll the child to pre-primary education. You can also use the same application to apply for a service voucher for early childhood education. To do this, you have to apply for a place in early childhood education at a service voucher unit. Information on the guardian's children is automatically retrieved from the Digital and Population Data Services Agency and displayed in this view.

Preschool education in Finnish and Swedish begins in August, and the date varies annually. You can see the start date for preschool education on the application and on the espoo.fi website.

Need for early childhood education connected to pre-primary education

If necessary, apply for early childhood education connected to pre-primary education for your child (fees apply). Early childhood education is provided in the morning before pre-primary education and in the afternoon after pre-primary education during the opening hours of the pre-primary education unit. (As a rule, pre-primary education is provided from 9:00 to 13:00.)

If your child needs early childhood education at the beginning of August before pre-primary education starts, take this into account when choosing your desired start date.

You can apply for connected early childhood education from the same unit (municipal or service voucher) from where you apply for pre-primary education.

When applying for private pre-primary education units, apply for related early childhood education directly from the unit (with the exception of service voucher units); the units inform customers about the application procedure. If you have applied for related early childhood education from a private unit on the pre-primary education application, the service guidance will change your application to a pre-primary education application only.

A separate written decision will be issued on the early childhood education place. The decision will be sent to the [Suomi.fi Messages](#) service or by post if you do not use the [Suomi.fi messages](#) service.

If your child needs early childhood education at the beginning of August before pre-primary education starts, you can apply for it on this application by selecting I also apply for early childhood education related to pre-primary education.

Also enter on the application your child's early childhood education time, including pre-primary education. The time will be further specified in August on your service agreement.

Need for support

If your child needs support in learning Finnish and your current day-care centre has recommended preparatory pre-primary education for your child, please make a note of this on your application. This is not applicable to Swedish-language pre-primary education.

Preparatory education is offered in connection with pre-primary education to children who do not yet have Finnish language skills or who know some Finnish. Preparatory education is offered to children of pre-primary education age in Finnish-speaking municipal pre-primary education groups.

Children attending extended compulsory education are not entitled to preparatory education. If the child has received or later receives a decision on extended compulsory education, the child's placement will be changed to a pre-primary education placement.

Please also make a note on your application if your child needs support. The support will be implemented in the child's daily life as part of the other activities of pre-primary and early childhood education.

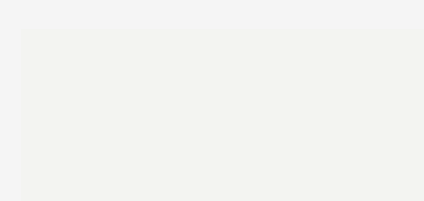
