The open data resources can be found and handed over via the Internet. Open data resources are not delivered or worked on at the customer's request as customer service work. The use and publication rights are determined according to the open licence of the data concerned.

Materials on the topic of open data can be obtained from customer service and various service portals free of charge, however, a service fee will be charged as customer service or service portal service for their delivery.

Starting from 1 June 2021 until further notice, no fee will be charged for the use of the city's own interface in terms of open interface materials.
